**Position:** Full-Time Counselor

**Position Summary:** Full-time Counselor to work with adult women seeking help for issues including (but not limited to): depression, anxiety, marital issues, past trauma, spiritual issues and concerns, identity.

**Duties & Responsibilities:**

- > Caseload: Approximately 22-25 sessions completed per week
- > Commit to providing 4-6 “after-hour” sessions, typically offered in the evening but early morning sessions are also considered after-hours.
- > In addition to the routine clinical tasks outlined below, Counselors at RPC must be skilled and/or teachable in regularly integrating faith, scripture, and spiritual disciplines into the counseling process.
  - Complete an initial intake that includes assessing and diagnosing the client
  - Rely on experience and judgment to create treatment plan & accomplish goals

- Assist the client in identifying issues for the treatment plan that will be addressed in therapy
- Work collaboratively with other members of client's treatment team (psychiatrist, medical doctor, family members, significant others as identified by the client)
- Protect the client's confidential information
- Complete the required documentation in practice management software (TheraNest) to monitor the identified client's progress and ensure that all documentation is in the client's file within the time frame established by agency (24 hours)
- Distribute client evaluations of treatment progress and satisfaction with services at regular (assigned) intervals and appropriately report scores
- > Prepare for, attend, and participate in individual and group supervision

**Qualifications:**

- > Required: LCMHC or LCMHC-A in the state of NC (LCSW or LMFT encouraged to apply as well)
- > Preferred: Degree received from an accredited Christian Counseling program and/or experience practicing counseling with an integration of Christian faith
